Yankee Virtual 2021 Was a Real Success

In late January, the dental community came together like never before for the first-ever all-digital Yankee Dental Congress. Held from January 28-30, 2021, in offices, home offices, and living rooms all over New England and beyond, Yankee Virtual 2021 provided continuing education (CE), networking opportunities, and an Exhibit Hall for attendees to access at their own pace. What's more, attendees were able to access CE courses on the virtual platform through March 1. New England's largest dental meeting (and the fourth largest in the country), Yankee has been a cornerstone of the Massachusetts Dental Society (MDS) since 1976, and the MDS staff and volunteers who worked hard to put the conference together were determined that the COVID-19 pandemic was not going to change that. They pivoted from producing the beast of a show that is the in-person Yankee to working on the horse of a different color—a virtual show—in a matter of months. Their hard work paid off: Attendance at the three-day event exceeded the number of attendees at the American Dental Association's (ADA) virtual meeting in October.

"For the first time in the MDS's history, we hosted a large-scale virtual convention, which included high-quality dental education and an Exhibit Hall," says MDS Executive Director Kevin Monteiro, CAE. "We had more than 8,000 registered attendees and 86 corporate partners participate in Virtual Yankee."

Another positive result of a virtual conference was echoed by multiple attendees on the virtual platform's message boards: Winter weather and traffic



weren't issues this year as participants enjoyed Yankee from the warm comfort of their homes and offices.

"Moving Yankee Dental Congress to an online platform was not something we had ever planned to do," says Shannon McCarthy, MDS managing director of business development and Yankee Dental Congress. "However, we quickly realized that it was necessary in this new world of ours. Although an

House of Delegates Holds First Virtual Annual Session

For the first time ever, the Massachusetts Dental Society (MDS) House of Delegates Annual Session was held virtually on Wednesday, January 27, 2021. Held the evening before Yankee Dental Congress, the 157th Annual Session was a chance for voting members to get together—albeit through computer screens—for the first time in a full year.

The virtual House was presided over by Speaker of the House Dr. Raymond K. Martin, who was pleased with everyone's ability to come together under less-thanideal circumstances. "The MDS pivoted due to the pandemic to create a unique virtual environment to conduct the business of the Society," he says. "The staff,

Officers, delegates, and guests all pulled together to create a successful House of Delegates experience."

The House voted to pass three resolutions, including one approving a full-time dental school faculty dues discount. A virtual election for Vice President was also held, as two candidates former South Shore District Trustee Dr. Abe Abdulwaheed and Metropolitan District member and former Guest Board Member Dr. Frank Schiano—ran for the position of Vice President of the Board of Trustees. After the two candidates delivered brief speeches, Speaker of the House Dr. Martin instructed Delegates on the online bal-

lot voting procedure. After the Delegates voted and the tabulations were completed, Dr. Abdulwaheed, a general dentist in Quincy, was elected Vice President.

The new slate of Officers, who will begin their terms on July 1, 2021, per MDS governance structure, was installed by ADA First District Trustee Dr. Richard Rosato: Dr. Meredith A. Bailey (President); Dr. Abe Abdulwaheed (Vice President); Dr. Raymond K. Martin (Speaker of the House); Dr. Philip B. Howells (Treasurer); Dr. James Lee (Secretary); and Dr. MaryJane Hanlon (Immediate Past President).

Dr. Hanlon spoke to the resiliency shown by the membership in a challenging year overshadowed by the COVID-19 pandemic. "Thank you for answering the call

from our communities, from our medical colleagues, and from the MDS Board of Trustees and staff to support in any way you could," said Dr. Hanlon. "I am incredibly proud call our members my friends and colleagues, and look forward to continuing our collaborative efforts of ensuring that dental professionals have a seat at the table when it comes to decisions across the Commonwealth that directly impact the dental profession."

In her address to the House, Vice President Dr. Bailey reminded delegates that

there is still work to be done. "Throughout the pandemic, dentistry has demonstrated resiliency and the ability to adapt quickly to changes," she said. "But we are at a critical time and must prepare for what is next by being forward thinking." (Read Dr. Bailey's address in its entirety below.)

Meredith A. Bailey, DMD, was ceremonially sworn in as the 158th President of the Massachusetts Dental Society at the virtual House of Delegates on January 27, 2021. Per the Society's governance transition guidelines, Dr. Bailey won't take office until July 1, 2021.



It is a privilege and an honor to be the 158th President of the Massachusetts Dental Society, and the first two-yearterm President.

When I take office in July, the first phase of the governance reform will be complete, eliminating the Executive Committee and solidifying a Board of Trustees completely comprised of Regional Trustees. online platform will never replace hands-on courses, networking, and social interactions with colleagues and friends, Yankee Virtual 2021 was extremely well-received and gave us the opportunity to bring world-class CE right to our backvard."

This year's Yankee theme "Changing the Game" was selected two years ago, but the staff and volunteers who came up with the theme didn't anticipate just how much the game would be changed this year. "A big shout out and thank you to the 8,000-plus registrants of the first-ever Yankee Virtual," says Yankee 2021 General Chair Dr. Cherie C. Bishop. "You all helped us to 'Change the Game' at this exciting event. Converting Yankee to a virtual digital platform was a big challenge that was so wonderfully executed by both our loyal Yankee volunteers, as well our *amazing* MDS/Yankee staff. The educational program was top notch and the Exhibit Hall was cool and interesting to visit."

Must-see CE events at Yankee Virtual included programs such as "Organization for Safety Asepsis and Prevention (OSAP) Dental Infection Control[™]" and "What's The Plan? Contingency Planning For Business Disruptions." OSAP's "Safest Dental Visit[™]" highlighted and supported safe dental visits, with topics on principles of infection control, CDC guidelines and OSHA regulations, and dental unit water quality. The day wrapped up with a panel discussion incorporating updates and insights from governmental agencies. In the "What's The Plan? Contingency Planning For Business Disruptions," dental professionals discovered strategies and resources for creating a contingency plan to maintain practice viability in the event of future disruptions and discovered the tools and systems necessary to safeguard continuity of patient care, team safety, and success of the practice.

"We were fortunate to have some of the best speakers in dentistry still able to speak to our attendees virtually," says Dorrey Powers, MDS director of continuing education and programming. "The Continuing Education Program surpassed expectations, and we were able to fit everyone's needs."

Basic Auditorium and the Power Auditorium. Members who purchased the all-inclusive Power Pass were able to attend courses in both auditoriums, and as a special bonus, the first 1,000 ADA members and their staff to register for the Power Pass were eligible to receive a complimentary PPE Supply Kit that included exhibitor samples, 10 N95 masks, one fit test kit, and five face shields. The PPE Supply Kits were mailed to eligible recipients in mid-February.

For those looking to shop for products and services, the virtual Exhibit Hall featured 86 exhibitors offering show specials and company representatives at the ready. This platform gave attendees the opportunity to watch videos, download informational materials, and connect with exhibitors. Instead of tracking down an exhibitor or representative in a large convention center, virtual conference attendees had many opportunities for direct communication, instant messaging, and impromptu conversations at the click of a button. And as with the CE portion of Virtual Yankee, the virtual Exhibit Hall remained active until March 1 for continued connections.

It's not Yankee without a little bit of socializing, and Yankee Virtual filled that need with opportunities for members to connect on a personal (albeit virtual) level. The Networking Lounge was a great spot to chat via messaging with fellow attendees, with the option to post comments to the large group of attendees or one-on-one. One of the highlights for Yankee attendees is getting the chance to connect with friends and former classmates from dental school, and that didn't change either. Alumni from the Boston University Henry M. Goldman School of Dental Medicine, Harvard School of Dental Medicine, Tufts University School of Dental Medicine, and UConn Dental School were able to join their classmates at each school's virtual Dental School Alumni Reception to hear updates from the dean and take part in breakout sessions to network, mingle, and connect with one another on Friday, January 29.

Yankee Virtual continued to provide other networking and social opportunities. "After taking our CE courses, we were entertained by James Beardwinning Chef Barbara Lynch cooking a meal over Zoom in her own kitchen," says Dr. Bishop. "And we were also able to enjoy an educational and delicious wine and cheese tasting, as well as a fun and interesting Lake Champlain chocolate tour, or indulge in some self-care with yoga and meditation."

It's a year of firsts for Yankee, as the New England dental community is setting its sights now on Dentalpalooza, the first-ever outdoor Yankee event held outdoors at the Lawn on D in Boston on Friday, June 4. HSDM Wins ASDA District 1 Student Debate

Yankee Virtual 2021 closed out with the MDS and the American Student Dental Association (ASDA) 12th Annual ASDA District 1 Student Debate on Saturday, January 30, 2021. Debate teams from the Boston University Henry M. Goldman School of Dental Medicine (BUGSDM), University of Connecticut School of Dental Medicine (UConn), Harvard School of Dental Medicine (HSDM), Tufts University School of Dental Medicine (TUSDM), University of New England College of Dental Medicine (UNE), and a pre-dental team faced off to argue pertinent policy and ethical issues that confront students and practitioners alike.

Due to the pandemic and the virtual nature of Yankee 2021, the first three rounds of debate were taped and presented on the MDS YouTube channel in the weeks leading up to the final round. Round 1 featured BUGSDM and UNE debating discipline-based numerical clinical requirements; round 2 saw TUSDM vs the pre-dental team debate the expansion of Medicare to cover dental services; and round 3 saw HSDM vs UConn debate the use of teledentistry. In the final round, HSDM and UConn battled it out once again, this time on the topic of whether dentists should share their work on social media. Congratulations to HSDM's Joe Montesano and Sophia Yang for winning the title of Debate Champions.

MDS Membership Year in Review: 2020

MDS Foundation Awards Grants to Five Oral Health Programs Across Massachusetts

The Massachusetts Dental Society (MDS) Foundation has awarded a total of more than \$66,000 in "Expanding Access to Dental Care" grants to five organizations in Massachusetts. The goal of the grants is to improve the oral health of residents of the Commonwealth by supporting sustainable programs that improve access to dental care. The following organizations received grants:

- The Cambridge Health Alliance (CHA) Foundation of Cambridge has been awarded \$15,000 to continue its work helping newly immigrated youth at Somerville High School access oral health care. The funding will be used to expand access to restorative dental care to a larger population of teens who need treatment, and will also allow CHA to coordinate assessment, cleanings, and fluoride treatments at Somerville High School or an alternate location.
- The Dental Lifeline Network (DLN), a national charitable organization based in Denver, has been awarded \$6,250 to support the expansion of the Massachusetts Donated Dental Services (DDS) program, which began in 2008 on a small scale. This funding, along with matched funds by other supporters, will help DLN expand Massachusetts DDS into a robust statewide program by providing funding for one fiscal year. The funds will be used to employ a coordinator that will help provide 31 patients with \$84,000 in donated treatment, further develop the network of volunteer dentists and dental labs in Massachusetts and employ a program coordinator.
- The Forsyth Institute in Cambridge, on behalf of the ForsythKids Program, has been awarded \$15,000 to continue providing a mobile dental program that

seeks out patient populations that tend to have poorer oral health and more significant challenges accessing dental care. The funds will be used to provide teledentistry to safely reach more patients, as well as targeted in-person treatment for urgent dental conditions. The funds will also support oral health education to every child in the program via virtual classes.

- Tufts University School of Dental Medicine's Service With A Smile project has been awarded \$15,000 to help provide dental screenings and care to veterans in the Greater Boston area, primarily those who are experiencing homelessness. Service With A Smile provides oral health education, screenings, care, and/or referrals to dental homes.
- Volunteers in Medicine (VIM) Berkshires in Great Barrington has been awarded \$15,000 to help continue providing dental services to uninsured or underinsured, income-qualified residents in the Berkshires. The grant will also allow VIM to continue its concerted effort to attract dentists and dental hygienists into the Berkshire area to help address capacity building in the region, which is severely lacking in dentists and related dental care.

"After an especially difficult year, we are incredibly grateful for all of the MDS Foundation donors who made it possible for us to help support these five worthy organizations," says MDS Foundation Chair Dr. Robert Lewando. "Everyone deserves access to oral health care, and it is because of initiatives such as these that so many additional Massachusetts residents will benefit from improved and expanded services."

The MDS Reaches Out to BORID Regarding Non-Compliance Penalties

On February 24, MDS President Dr. MaryJane Hanlon sent a letter on behalf of all members to the Board of Registration in Dentistry (BORID) advocating against enhanced penalties for dentists who employ dental staff practicing with an expired license or without a license. The MDS has always strongly urged our members and their staff to comply with all rules and regulations set forth by BORID. At its March 3, meeting, BORID discussed the letter, and Dr. Hanlon was present at this meeting and addressed BORID questions. Following the discussion, BORID agreed not to enhance penalties at this time for dentists who employ dental staff practicing with an expired license or without a license. As a result, the MDS agreed to work collaboratively with BORID to address the licensing problem and to commence a comprehensive communications campaign to better educate members on licensing deadlines and requirements utilizing MDS email communications, website, social media channels, and other resources, with the goal of achieving the full compliance of licensing dental professionals.

Chair Dr. Michael Scialabba,

It has come to our attention that during its March 3, 2021, meeting, the Massachusetts Board of Registration in Dentistry (BORID) will consider enhancing the disciplinary action against dentists who employ dental staff practicing with an expired license or without a license. It is our understanding that this is being considered because BORID continues to see significant numbers of dental assistants who are practicing without a license or with expired licenses. The Massachusetts Dental Society (MDS) strongly urges all its members and their staff to comply with all rules and regulations set forth by the BORID. It deeply concerns us that this issue has not corrected itself now that several years have passed since the initial licensure regulations were promulgated.

As we understand it, there is not a significant number of dental practices that have had recurring issues (e.g., dentists being brought before BORID multiple times for employing dental team members without licenses or with expired licenses). Although we agree that non-compliance is concerning, the existing discipline structure appears to succeed in preventing repeat non-compliance. We fear that enhancing the penalty will not have the desired effect of decreasing the number of cases, but rather may cause those dentists to suffer substantial increases to malpractice premiums and negatively impact their reputation before the public, thereby adversely affecting their commercial viability and—most importantly—potentially hindering patients' access to care.

If the desired outcome is to protect the public by improving the rate of compliance on this issue, the MDS recommends we work collaboratively to address the major issue with a multipronged approach. The MDS proposes we undertake the following in hopes of helping BORID achieve that outcome:

- Distributing monthly emails regarding dental assistant licensure requirements and potential penalties imposed on both the employing dentist
 and the dental assistant if there is non-compliance
- · Hosting quarterly webinars featuring BORID members and/or staff discussing this issue, among other important
- BORID topics
- Sending biweekly emails beginning 90 days prior to dental assistant licensure renewal date and continuing 30 days past the renewal date
- Mailing one post card 30 days prior to the dental assistant licensure renewal date sent to every MDS member
- · reminding them of the dental assistant licensure renewal deadline
- Posting related information on MDS website, social media channels, and other MDS resources

The MDS supports BORID in its efforts to protect the public and hopes it can play a larger role in communicating the efforts of BORID moving forward.



Eye Strain and Technology

Over the past year, we all have been using technology more than ever to connect with colleagues, family, and friends as we social distance. As a result of the countless virtual meetings we've been participating in, our eyes have been subjected to an inordinate amount of blue light, which is emitted from computer and smart phone screens. Too much screen time can lead to difficulty sleeping, headaches, blurred vision, and dry eyes. The MDS Dentist Health and Wellness Committee suggests a few steps you can take to help minimize these harmful effects and protect your peepers:

• Lower the brightness or enable dark mode on your computer and phone screen or purchase a pair of blue light glasses. In the evenings, enable night mode to lessen the glare from your screens.



- Practice the 20-20-20 rule, which recommends that after 20 minutes of looking at a screen, you should look at something 20 feet away for 20 seconds.
- Keep the screen far away from your eyes and take periodic breaks from screens to rest your eyes. Many people benefit from using eye drops on days when the possibility of screen breaks is not possible.
- Make sure you are getting enough sleep, which for most adults means 7 to 9 hours of sleep per night.
- Be sure to schedule your annual appointment with your eye doctor.

MassHealth Restores Adult Benefits

The MassHealth Dental Program restored adult dental benefits effective January 1, 2021, due to the work of advocates and the legislature in Massachusetts. MassHealth members over the age of 21 are now able to access a greater number of dental services, including root canals and crowns, in addition to other important services such as preventive and partial/complete dentures, which were previously covered.

What this means for your MassHealth patients is that they are now able to have full preventive and restorative care. This is an important change to adult benefits as it expands the member's access to care. If you are a MassHealth provider, please be sure to educate your patients about these new benefits and refer to the updated Office Reference Manual and fee schedules located on the MassHealth provider web portal at masshealth-dental.net/Dentists. The CDC Updates Guidance for COVID-19

The U.S. Centers for Disease Control and Prevention (CDC)

has issued updated guidance that people fully vaccinated against COVID-19 no longer need to quarantine following a known or suspected COVID-19 exposure. Read the complete guidance at cdc.gov/vaccines/covid-19/info-by-product/ clinical-considerations.html.

Additionally, the CDC is now recommending that wearing two masks (aka, double masking) or a single tightly fitted mask is significantly better at blocking airborne particles than a single mask, based on results from a January study. The study found that one surgical or cloth mask blocked about 40% of the particles, while double masking and tighter-fitting masks blocked significantly more particles. Please share this recommendation with your office staff and patients who may typically only wear a single mask.

The FDA Decreases N95 Mask Decontamination Cycles to Four



In late January, the U.S. Food & Drug Administration (FDA) announced it was rolling back its emergency use authorization for N95 respirator decontamination systems. Masks may now only be decontaminated four times, a significant reduction from the early stages of the COVID-19 pandemic when personal protective equipment (PPE) was extremely limited and the FDA approved up to 20 decontamination cycles.

The agency revised the authorization after studies found that N95 masks are prone to failure after a high number of decontamination cycles. The FDA still recommends that each mask be labeled and worn by the same user after each decontamination cycle.

Volunteer Vaccination Opportunities

The Massachusetts Dental Society (MDS) is pleased to announce that there are several opportunities for dental professionals to volunteer at COVID-19 vaccination drives. We have compiled a list of these, as well as training resources, on our COVID-19 vaccine webpage. The list will be updated as new volunteer and training opportunities are identified.

Who Can Volunteer?

As dentists and dental hygienists, it is within the scope of practice to deliver vaccine injections. Retired dentists whose licenses have expired within the last 10 years may also volunteer as COVID-19 vaccinators. Office staff can volunteer to help with check-in and administrative roles.

Why Should You Help?

MDS members should be proud of the great service that dental offices have provided to our community during this pandemic. The MDS has been asked many times how we, as dentists and dental professionals, can help support our health care colleagues combat this disease. There is an enormous challenge underway to vaccinate our community, and dental professionals are in a unique position to help. Engaging dental professionals to volunteer as COVID-19 vaccinators will help reduce the burden on other health care providers and illustrate to the community that dental professionals are trained and willing to do our part to put an end to this pandemic.

Malpractice Insurance Concerns

Before signing up to volunteer, you should verify your coverage for vaccination administration with your malpractice insurance provider. Eastern Dentists Insurance Company (EDIC) has said that it will provide liability coverage for dental personnel who are already enrolled in EDIC who volunteer as

vaccinators. If you use another insurance carrier for your malpractice insurance, you should verify your coverage for vaccination administration with them.

In addition, the American Dental Association has submitted a letter to the U.S. Department of Health and Human Services (HHS) to request guidance regarding temporary liability protection for dentists who administer approved COVID-19 vaccines under the Public Readiness and Emergency Preparedness Act (PREP Act). The MDS will continue to monitor the HHS's response to this request.

The Board of Registration in Dentistry (BORID) has informed the MDS that dentists whose licenses have expired within the last 10 years (i.e., either through retirement or lapse) may volunteer as COVID-19 vaccinators at approved vaccination sites in Massachusetts. However, any dentist interested in doing so must submit a temporary reactivation application for the COVID-19 State of Emergency only. There is no fee for this licensure reactivation, and you will not need to meet reactivation requirements. The reactivation will expire 90 days after the termination of the State of Emergency. Don't Share Photos of Your **COVID-19** Vaccine Card

While it's tempting to want to encourage others to get vaccinated, the Better Business Bureau has issued a warning against sharing photos of COVID-19 vaccine cards on social media. The cards contain self-identifying information-full name, birth date, and vaccination details-that could make you vulnerable to identify theft.

Instead, consider sharing a photo of you receiving your vaccine or of a vaccine sticker. Use this also as a reminder to check your social media privacy settings and be mindful of answering surveys or creating posts on social media that require you to list your favorite things, which are often password hints or answers to security questions.



Question: Can I Mandate That My Staff **Get Vaccinated?**

Answer:

Now that the COVID-19 vaccines are finally here, many dental practice owners may be wondering if they can mandate that their dental staff get vaccinated. Locally, the Massachusetts Department of Public Health (DPH) is not mandating the

COVID-19 vaccine, but the DPH does stress that the vaccine has been shown to be highly effective at preventing illness and is an important tool in the fight against COVID-19 and in keeping your patients and community safe from continued spread of the virus. According to guidance issued by the U.S. Equal Employment Opportunity Commission, employers who want to encourage or possibly require COVID-19 vaccinations must comply with the Americans with Disabilities Act and Title VII of the Civil Rights Act of 1964. This means that if you implement a COVID-19 vaccine mandate in your practice, you must make exceptions for



employees who cannot be vaccinated due to a disability, medical complications, pregnancy, or sincerely held religious beliefs, and provide reasonable accommodations, such as allowing the staff person to work remotely or take a leave of absence.

Rather than implementing a vaccine mandate, the MDS advises practice owners to focus instead on educating team members on the public health importance of the vaccine and encouraging them to get vaccinated. To motivate team members to get vaccinated, practice owners could:

- Engage in a dialogue with team members to discuss the vaccine and its critical impact in slowing the spread •
- Set an example for staff and get the vaccine yourself
- Make obtaining the vaccine as easy as possible for staff
- Provide paid time off for staff to get vaccinated and recover from any potential side effects


Practice owners should take care not to alienate staff members who cannot or choose not to receive the vaccine. At the same time, all dental professionals need to remember that like other health information, whether or not someone has been vaccinated is protected by the Health Insurance Portability and Accountability Act (HIPAA).

It's also important to remember that all the safeguards put into place at the start of the pandemic (e.g., PPE, hand hygiene, disinfecting protocols, patient screening, social distancing measures, etc.) are still required since it's possible that not every staff member or patient will choose to be vaccinated. Remind your team members—even those who've received the vaccine—to continue to follow the recommended guidelines.

As you are aware, dentists are mandated reporters of abuse and neglect. The dental team's role in combating abuse and neglect includes recognition and referral. By being observant and reporting suspected cases, you can help shield your patients, both young and old, from violence and neglect. However, you may not be aware that the Massachusetts Office of the Attorney General's Victim Compensation and Assistance Division provides financial assistance to eligible victims of violent crime for uninsured medical and dental care, mental health counseling, funeral and burial costs, and income lost due to the inability to work.

If you have patients who may be victims of a violent crime, you should encourage them to apply for the Victim Compensation Program. The History of the Boston District Dental Society

This article originally appeared in the Fall 2020 issue of Boston District News, the online newsletter of the Boston District Dental Society. MDS CONNECTION is publishing it here to commemorate the formation of the MDS's 14th District.

2020 marked six years since the formal establishment of the Boston District Dental Society (BDDS), so we wanted to take time this issue to reflect on how far the District has come. We got a chance to sit down (via Zoom) with some of the founding members to pick their brains on the creation of this great District, where it started, and what they foresee for its future.

The Massachusetts Dental Society (MDS) has grown tremendously over the past 156 years, from a small like-minded group of dentists in the Boston area to a diverse organization of more than 5,000. In 1865, the Commonwealth of Massachusetts awarded the small group a charter to incorporate as the Massachusetts Dental Society. The First Annual Meeting was attended by 27 members. At that meeting, Dr. Nathan Cooley Keep was elected as the first President of the Society. Its mission was to improve the oral health of the public and to promote the professional development of its members.

Currently, the MDS has 14 Districts, and while it is the newest District, the BDDS has guickly become one of the largest and most diverse. The BDDS was formally established in 2015 at the MDS House of Delegates. However, its journey to formation began five years earlier in 2010. A resolution was introduced at the MDS House of Delegates to create a Special Committee to oversee the formation of a Greater Boston Pilot Group (BPG). The goal of the BPG was to explore the need for a new District, one that was different from the suburban communities of the Metropolitan District and incorporated the diverse needs of Boston practices. One of the founding members, Dr. Jan Rozen recounts that the "Special Committee was composed of five to seven members, two of whom were from the Metropolitan District Dental Society [MDDS], as well as a nonvoting Trustee Liaison and non-voting dental school liaison." Over time, the Greater Boston Pilot Group morphed into what was then called the Boston Collaborative Group (BCG).

Founding members are as follows:

The BCG consisted of an Executive Core group of Officers, a full Executive Committee, numerous at-large members, and one Trustee liaison:

- Dr. Mina Paul: MDDS Liaison
- Dr. Jan Rozen: Liaison between the BCG and the MDDS
- Dr. N. Peter Hjorth: MDS Trustee Liaison
- Dr. Frank Schiano
- Dr. Romesh Nalliah
- Dr. Nithya Chickmagalur
- Dr. Michelle Dempsey
- Dr. Joseph Guarino
- Dr. David Kim
- Dr. Omar Gonheim: MDS Guest Board Member (2013-2014)

The primary goals of the Boston Collaborative Group were to engage existing MDS members who worked and/or lived in the Greater Boston area and to create a potential outline and structure for a "viable Greater Boston District, while at the same time retain a viable Metropolitan District." Dr. Paul recounts that "the group had limited funds and ran much like a start-up in the early years. They had to develop parliamentary procedure and find funding and sponsorship. They also had to define the needs of the District and make sure that the Executive Committee that would follow them understood and would carry out this vision." She states that they were "careful about the guardianship

they were given to make sure they made the District a success. They worked hard to ensure they were targeting the 'right' people for the District and were faced with bridging the gap between the needs of older members and new members. This required diplomacy and experience, and a lot of time and dedication." The BCG met often and worked tirelessly to develop vision and mission statements that supported these goals:

- BCG Vision Statement: To increase representation of the diverse local community of dental professionals in Boston.
- BCG Mission Statement: To encourage and expand involvement and increase representation in organized dentistry through a committed engagement to relevant educational programs, community service events, and collegial networking.

The impetus to create the BPG, which then evolved into the BCG, and finally the BDDS, stemmed from Boston's unique attributes. Boston has three dental schools with notable faculty, numerous community health centers, and a diverse population of general practitioners and dental specialists.

"Dentistry was at a crossroads," says Dr. Rozen. "Looking forward, the scope of dentistry was changing. Would we be ready to accept the challenges that change will bring? A 'Greater Boston District' would be positioned to accept those challenges of representing organized dentistry by integrating its members with committed programs for continuing education, community service events, and collegial networking."

Throughout its existence, the BCG worked hard to provide an assortment of relevant programming and leadership opportunities to its members and

the community. It leaned toward hosting more social gatherings versus continuing education (CE), as it was mindful that CE was available online. It realized this demographic was more interested in connecting face to face and establishing networks due to location in Boston. It saw steady increases in participation and membership as the BCG grew. This was all through word-of-mouth marketing and social media-and showed the MDS that Boston was long overdue for its own District. Due to the progress of the BCG, a Boston Task Force was formed comprised of the Executive Core Leadership of the BCG and the Executive Core Leadership of the MDDS. This Task Force was charged with working closely with the MDDS leadership to develop and finalize the formation of the new "Greater Boston District." Over a six- to 12-month period, the BCG and MDDS created infrastructure for transitioning to a full District structure, with the idea of bringing a resolution to the 2015 House of Delegates. The Task Force's work was successful, and the Boston District Dental Society was established at the 2015 MDS House of Delegates Annual Session.

The BDDS includes the city of Boston and the following neighborhoods: Allston, Back Bay, Bay Village, Beacon Hill, Brighton, Charlestown, Chinatown, Dorchester, Downtown, Fenway, Hyde Park, Jamaica Plain, Kenmore, Mattapan, Mission Hill, North End, Roslindale, Roxbury, South Boston, South End, West End, and West Roxbury.

The Executive Core Leadership of the newly minted Boston District Dental Society was led by Drs Jan Rozen, Mina Paul, Meredith Bailey, Zachary Peacock, and Sheede Ciccarese. These leaders worked to uphold the principles developed by the BCG and maintain the Vision and Mission Statements previously developed. The founding members were passionate about the

future of the BDDS, and that passion shows in the growth of the District over the years. "Creating a District from scratch and watching it grow organically over the last five years has been a very rewarding experience," says Dr. Meredith Bailey, BDDS Chair (2018-2019) and current MDS Vice President. "The enthusiasm and dedication of the District leadership has led to growth and increased involvement of the membership."

The current BDDS Vision and Mission statements are as follows:

- BDDS Vision Statement: The BDDS is a component society of the MDS that serves to provide value to our members through communication, networking, and education.
- BDDS Mission Statement: Helping the MDS connect on a local level.

The BDDS is now in its sixth year of governance, with parliamentary protocol well established under the guidance and mentorship of former Trustee Dr. Paul. "2020 [marked] the implementation of the new governance reform happening at the state level to create a more agile and modernized Board," says Dr. Bailey.

The District is led by strong leadership, well equipped to meet the changing needs of dentistry, especially during the current COVID-19 pandemic. Membership support and involvement is also robust, allowing the BDDS to achieve the highest numbers in membership across the Districts. We would love to thank Drs. Jan Rozen, Meredith Bailey, and Mina Paul, among others, for their time and knowledge in developing this article.


